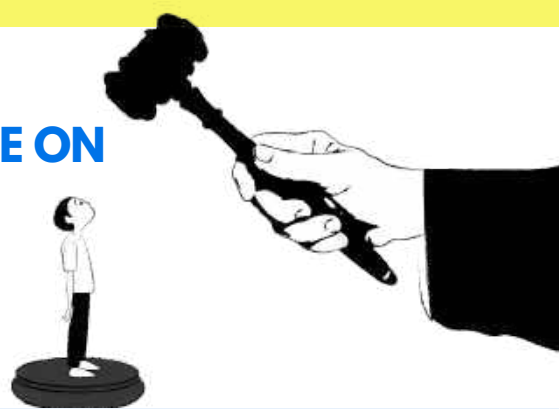

TWO-DAY INTENSIVE E-LEARNING CERTIFICATE COURSE ON JUVENILE JUSTICE (CARE & PROTECTION OF CHILDREN) ACT, 2015 COUPLED WITH FIELD STUDY



Background

Center for Child Rights, NUSRL, Ranchi is a Center that fosters child rights in Jharkhand with the support from and in collaboration with the UNICEF. It aims to become a center of excellence for Child rights in the times to come by providing support to the stakeholders.

To reach out to wider stakeholders, the Center is organising "Two-day Intensive e-Learning Certificate course on Juvenile Justice (Care and Protection of Children) Act, 2015' Coupled with Field Study. This course would help in disseminating the knowledge about the Juvenile Justice System in India and strengthening its implementation in Jharkhand State.

Course Objectives

The overall objective of the course is to enhance the understanding of the direct and indirect stakeholders and duty bearers dealing with children on Juvenile Justice (Care & Protection of Children) Act, 2015 including its institutionalized framework of the Juvenile Justice system. Through this certificate course Center for Child Rights (CCR) is intended to disseminate knowledge about the international framework relating to juvenile justice care and protection and its related principles with sole focus on care and protection of Children in Conflict with Law (CCL) & Children in Need of Care and Protection (CNCP).

This course will provide an in depth understanding on the legal framework relating to adoption and will familiarize the participants with the Juvenile Justice (Care & Protection of Children) Model Rules, 2016, Jharkhand Juvenile Justice (Care & Protection of Children) Rules, 2017 along with Jharkhand Guidelines for Sponsorship of Children, 2018. Through field work CCR is looking forward to provide practical understanding about the juvenile justice system at the grass roots level to the participants.

- Module – 1: Introduction to Juvenile Justice System (01 Hr)
- Module – 2: International instruments related to Child & Law and Principles of Care & Protection of Children (01 Hr)
- Module – 3: Institutional framework and administration of juvenile justice relating to Children in conflict with law & Child in need of care and protection (03 Hrs)
- Module – 4: Rehabilitation, Social Reintegration & Standards of care and protection (03 Hrs)
- Module – 5: Institutional & Non- institutional Framework related to Adoption (02 Hrs)
- Module – 6: Miscellaneous aspects related to child (01 Hr)
- Module – 7: Orientation for the field work (01 Hr)
