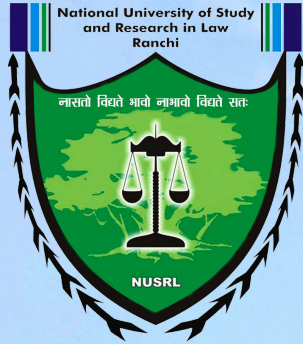

- 3. Bhartiya Sakshya Adhiniyam 2023: Contemporary Issues & Challenges**

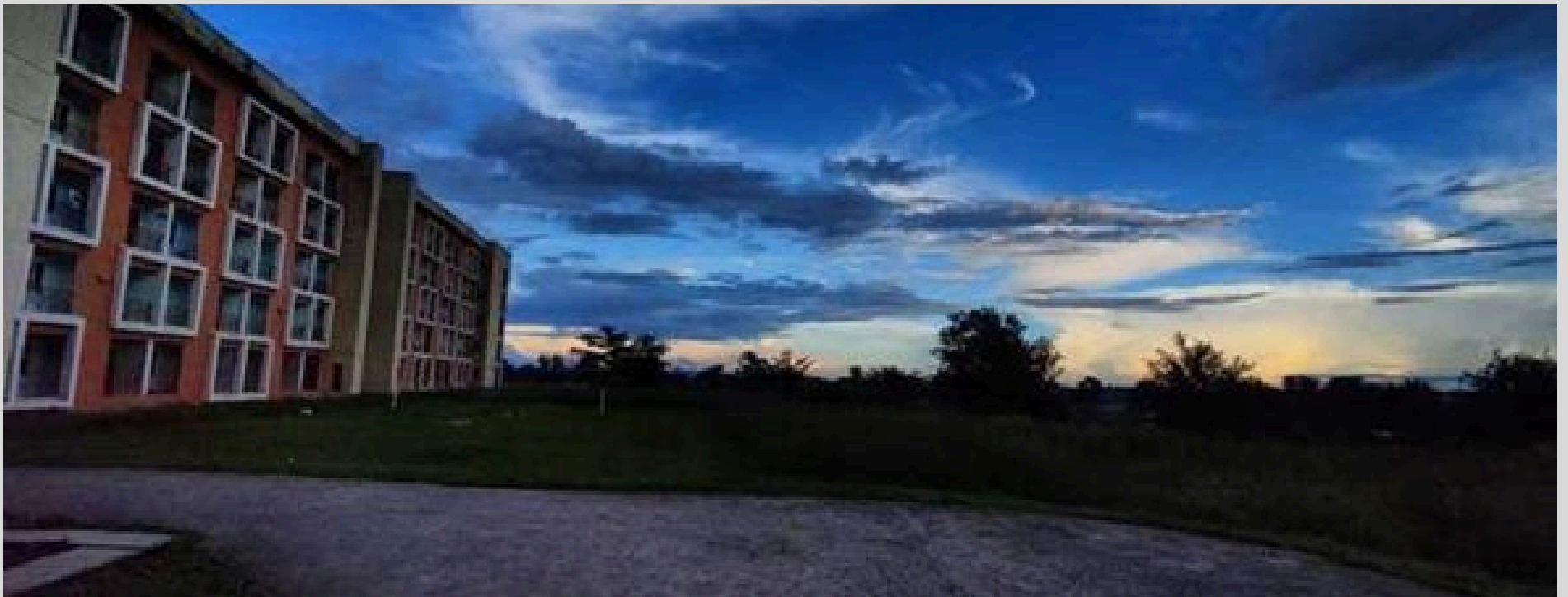
