# Eligibility Criteria for Bidders.

- 1. The Architect should have Graduate/Post Graduate/ Diploma/Degree in Architectural/Respective Branch of Engineering either from India or abroad.
- 2. The Architects should be member of (i) Council of Architecture or (ii) Indian Institute of Architecture or (iii) Institute of Engineers or (iv) any other professional Institute. For Civil and furnishing works the consultants/ Architect/Architectural firm should be registered with Council of Architecture.
- 3. If the firm is partnership firm or limited company then at least one partner/ Director shall be registered with Council of Architecture.
- 4. The Architects/ Architectural firms must have necessary office setup with supporting staff for consultation/ furnishing required help in getting plans sanctions etc. approved from the local development/ Municipal/Corporation authorities, fire department and forest department etc.
- 5. Other Mandatory Criteria-:
  - a. Three plus years of Proven experience quality architectural and project management experience.
  - b. Excellent technical drawing skills.
  - c. Strong communication skills.
  - d. Understanding and knowledge of Building codes, zoning, building construction, building systems and site requirements.
  - e. Architecture/ Architectural firms Registered with CPWD/ Local Construction Department.
