#### **INSTRUCTION TO THE TENDERERS**

- 2. The Bidder though technically qualified and whose financial offer is the lowest, fails to convince the Tender Evaluation Committee of his capability, capacity, credibility, his offer may be reviewed, and the Bidder intimated accordingly. In such case, the Bidder, who has quoted the lowest price, may be considered and his price may be negotiated as advised by the tender committee.
- 3. The rates shall be including labour, material carriage etc. at site & including necessary framing, fixtures & scaffolding etc. including all complete. Agency has to supply the material as approved by Engineer In charge.
- 4. The tenderers should quote in figures as well as in words the rates and amount tendered by them. In case of any discrepancy between rates quoted in figures and words, the rate on which the amount has been worked out shall be taken as correct. If the contractor does not work out the amount of any item or it does not correspond with the rate written either in figures or in words then the rate quoted by the contractor shall be taken as correct. The rates in "words" shall prevail over rates in figures" in case of discrepancy between the two
- 5. The agency is advised to inspect and examine the site and its surrounding thoroughly and satisfy him-self before submitting his offer means access to the site, the facilities available at site etc. In general, they shall themselves obtain all required information as to the risks, contingencies and all other circumstances, which according to them may influence or affect the rates.
- 6. The tenderer shall be deemed to have visited the site and made themselves familiar with the working conditions and to have the knowledge of the site.
