The position is for an initial period of three months, which can be extended to one year based on satisfactory performance. The contract may be further extended annually depending on the performance of the candidate and the needs of the IPR Chair.

About the IPR CHAIR: The Chair on IPR is instituted by the Department for Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry, Government of India with the vision to "facilitate Intellectual Property Education and Research". The chair on IPR was instituted by the DPIIT at NUSRL, Ranchi in this year 2023. The overall objectives of the IPR Chair are laid down in the Scheme for Pedagogy and Research in IPRs for Holistic Education and Academia (SPRIHA).

Role and Responsibilities of the Research Assistant (RA): The selected RA will provide support to the IPR Chair in conducting its research and education activities. As part of the assigned research the RA is expected to engage in diverse research activities including fieldwork, data collection, data analysis, report drafting, etc., RA is also expected to supervise the work of the student researchers/ interns associated with the IPR Chair and /or assist principal investigators in conducting research. RA is also expected to assist in other research and dissemination activities such as outreach activities and awareness programs of the IPR Chair.

Qualifications: Candidates who hold a Graduate (LLB) and post-graduate Degree in Law (LLM) and pursuing a PhD in Intellectual Property Law with a demonstrable interest in interdisciplinary research in Intellectual Property are only encouraged to apply.

Salary will be commensurate with the above qualifications is – Rs.25,000/- per month;
