1. The details of services for which tenders are invited from interested Reputed/Registered vendors /Firms are provided in Annexure “A” attached herewith.
2. Interested Contractors may contact NUSRL Establishment section for any clarification.
3. The details of eligibility for empanelment is indicated in **Annexure -1**.
4. Parties may send their completed applications in the prescribed format as indicated in **Annexure -2**. along with the completed Application Form, Bidders must affix the following documents indicating their eligibility. Capacity and experience to provide service for which they seek empanelment.
  - i) Company Profile.
  - ii) Copy of GST Registration Certificate.
  - iii) Copy of PAN Card.
  - iv) Copy of MSME Certificate (if applicable)
  - v) Certified copies of audited financials for last three years ending on 31.03.2023
  - vi) Copy of address proof of the office/Premises from where the business is operated.
  - vii) Performance Certificate/ Work order/ Purchase orders at least recent three clients who have entrusted relevant work to them during the last three years. (Similar type of works). They should work with educational Institutions.
  - viii) Applicants must affix one copy of each of the Firm/ Company registration certificate as per existing norms.

8. Firms selected for supply of **Gym Equipment** to the University which shall govern the terms and conditions of the Contract.
9. The applications received after the due date or incomplete applications will not be entertained.
- 10 Vendors/ Firms shall accordingly submit quotations on the basis which the university shall select one or more suitable Contractors to carry out. The University shall not bind itself to accept the lowest quoted rate. The university shall accept the quotation that is in best of interests of the University, as determined by the University authorities. The University reserves the right to not accept of the quotations submitted during this process.
- 11 The university shall issue a work order indicating the scope of work, commercials and timeline to selected contractors for carrying out of the work.
- 12 Firms/ Vendors shall follow all safety rules and security procedure that are in force and applicable during the execution of work.
- 13 Firms/Vendors shall comply with applicable provisions of all acts, statutes, rules and regulations of Central and State Government, as the case may be.
